Should any failure to conform to this warranty occur during a period of twenty-five (25) years after the date of installation, **SWEETWATER STEPS** shall, upon prompt, written notice, and compliance by the customer with such instructions as **SWEETWATER STEPS** shall give with respect to the return of the defective Pool Steps, replace defective Pool Steps with Pool Steps of substantially the same type and character.

SWEETWATER STEPS EXPRESSLY DISCLAIMS ANY AND ALL LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING FROM, OR ARISING OUT OF, THE USE OF THE POOL STEPS. ADDITIONALLY P.I. INC. SHALL NOT BE LIABLE FOR LABOR TO REPAIR OR REPLACE DEFECTIVE POOL STEPS NOR FOR ANY DAMAGE DONE TO THE POOL OR ANY RELATED FACILITIES AS A RESULT OF FAILURE OF THE POOL STEPS.

THE FOREGOING LIMITED WARRANTY IS EXCLUSIVE AND EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES EITHER EXPRESSED OR IMPLIED, ARISING BY LAW OR OTHERWISE. SWEETWATER STEPS EXPRESSLY DISCLAIMS THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

This warranty shall apply only within the boundaries of the continental United States. All disputes not resolved under the warranty outlined above and not barred by applicable statutes of limitation or otherwise barred by law, including but not limited to the terms of the warranty and all clauses herein contained.
