FIRST AID

DIRECTIONS FOR USE
It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read entire label and use strictly in accordance with precautionary statements and directions.

FOR SWIMMING POOLS
When used as directed, this product is effective as a swimming pool water sanitizing agent.
Ensure all pool equipment is working properly. Backwash the filter system following manufacturer's directions. Adjust pH to between 7.2-7.6. Add stabilizer to establish a minimum level of 30-40 ppm to reduce the degradative effects of sunlight upon the chlorine residual. Check for metals. Before using this product, add stain and scale inhibitor to prevent staining of pool surface due to metals. When using other products as outlined in the directions for this product, always follow directions on those products.
With pump running, broadcast 4 ounces of this product per 10,000 gallons directly into the water in the deep end of the pool as an initial treatment. Repeat additions until a residual of 1-3 ppm chlorine is established as determined by the use of a test kit. To prevent damage to pool surface, use a pool brush to disperse granules that may have settled to the bottom of the pool. NEVER ALLOW UNDISSOLVED PRODUCT TO REST IN CONTACT WITH BLEACHABLE POOL SURFACES.
Regular use of a test kit is necessary to determine when it is necessary to add another dose of this product to maintain a residual of 1-3 ppm available chlorine in the pool water. An average daily dose requirement is 2-3 oz. of this product per 10,000 gallons of water. After use of this product it is recommended that a preventative algae treatment be added on a weekly basis.
SUPERCHLORINATION: Broadcast one pound of this product per 10,000 gallons directly into the water in the deep end of the pool. To prevent damage to pool surface, use a pool brush to disperse any granules that may have settled to the bottom of your pool. NEVER ALLOW UNDISSOLVED PRODUCT TO REST IN CONTACT WITH BLEACHABLE POOL SURFACES.
In water temperatures less than 70°F, or as an alternate application procedure, predissolve this product prior to applying evenly to the deep end of the pool. Dissolve this product outdoors, in a clean plastic bucket stirring with a clean plastic or wooden spoon. Add this product to water; NEVER add water to product. NEVER add more than 1 pound of this product to less than 3 gallons of cool water. Do not mix with other products when predissolving.
Note: Re-entry into treated swimming pools is prohibited above levels of 3 ppm chlorine due to risk of body injury.

SWIMMING POOL ALGAEICIDE
When used as directed, this product kills algae and will rid your pool of unsightly algae spots. This product is ideal for use in vinyl lined, fiberglass or colored plaster surface pools.
Ensure all pool equipment is working properly. Backwash the filter system following manufacturer's directions. Adjust pH to between 7.2-7.6. Check for metals and if present add stain and scale inhibitor to prevent staining of pool surface. When using other products as outlined in the directions for this product, always follow directions on those products.
Before using this product, brush all surface-clinging algae paying special attention to pool steps, ladder steps and around skimmer and lights. At night or when the pool is not in use, broadcast this product directly into the water into the deep end of the pool with the pump running. Use two pounds of this product per 10,000 gallons for medium to heavy growth or one pound per 10,000 gallons for light algae growth. To prevent possible damage to pool surface, use a pool brush to disperse any granules that may have settled to the bottom of the pool. Brush any remaining algae and clean/backwash filter. If algae is still visible, repeat treatment.
Note: Re-entry into treated swimming pools is prohibited above levels of 3 ppm chlorine due to risk of body injury.

STORAGE AND DISPOSAL

Keep this product dry in its tightly closed container when not in use. Store in a cool, dry, well-ventilated area. Keep away from heat or open flame. Nonrefillable container. Do not reuse or refill this container. Rinse empty container thoroughly with water to dissolve all material prior to disposal. Offer for recycling if available. Do not contaminate food or feed by storage or disposal of cleaning of equipment. FOR DISPOSAL OF A CONTAMINATED OR DECOMPOSING PRODUCT SEE EMERGENCY HANDLING.

EMERGENCY HANDLING: In case of contamination or decomposition - Do not reseal container. Immediately remove container to an open and well-ventilated outdoor area by itself. It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.
Users are recommended to wear waterproof gloves when applying this product to pools, spas, or hot tubs. Suggested glove types include butyl and nitrile.
Before draining a treated pool, spa, or hot tub, contact your local sanitary sewer and storm drain authorities and follow their discharge instructions. Do not discharge treated pool, spa, or hot tub, water to any location that flows to a gutter or storm drain or natural water body unless discharge is allowed by state and local authorities.
This product is used to control the growth of algae in swimming pools, exterior spas, whirlpools, and hot tubs. For maximum effectiveness, pools, spas, whirlpools and hot tubs containing heavy growth of algae must be cleaned prior to using this product.
For pools having just visible algae growth, add an initial dose of 11 to 17 fluid ounces of this product per 10,000 gallons of water and remove settled algae debris by cleaning.
For treatment of freshly cleaned and filled pool, add initially 6 to 11 fluid ounces of this product per 10,000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of this product per 10,000 gallons of water must be made every 5 to 7 days after initial treatment for maintenance.
Spas, whirlpools and hot tubs having just visible signs of algae growth require an initial dose of 1 to 2 fluid ounces of this product per 1,000 gallons of water. For treatment of freshly cleaned spas, whirlpools or hot tub, add initially 0.6 to 1.1 fluid ounces of this product per 1,000 gallons of water. Subsequent additions of 0.2 to 0.4 fluid ounces of this product must be made every 5 to 7 days after initial treatment for maintenance.
This product is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. This product can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix with concentrated dry or liquid chlorine products.
FOR WINTER ALGAE CONTROL: This product will prevent the growth of most algae during the off season winter months when pools are not in use. For pools which have been properly treated during the swimming season and are free of visible algae, add 6 ½ to 13 ounces of this product per 10,000 gallons of water. For pools having some visible algae growth at the end of the swimming season, add 13 to 19 ounces of this product per 10,000 gallons of water. Distribute this product uniformly throughout the pool to ensure maximum effectiveness. If the pool is not covered, it may be necessary to repeat the treatment one or more times during the season.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **Pesticide Storage:** Keep this product dry in its tightly closed container when not in use. Store in a cool, dry, well-ventilated area. Keep away from heat or open flame. **Pesticide Disposal and Container Handling:** Nonrefillable container. Do not reuse or refill this container. **If empty:** Place in trash or offer for recycling, if available. **If partly filled:** Call your local solid waste agency for disposal instructions.
